- 2. Further, I release and forever discharge Sopris Mountain Ranch Homeowners' Association, Inc., its officers, directors, shareholders, agents, representatives and employees, Craig Sakin and Sally Sakin (the "Released Parties) from any and all liability, claims, demands or causes of action that I may hereafter have for injuries, permanent disability (including paralysis), death, or loss or any damage whatsoever to my person or property arising out of my participation in the Activities, including but not limited to, losses caused by the negligence of the Released Parties.
- 3. I agree that I will not sue, make any claim against, maintain an action against or recover from the Released Parties for any injuries, death, permanent disability (including paralysis), loss or damage to my person or property sustained as a result of my participation in the Activities. I agree to indemnify and hold the Released Parties harmless from all claims, judgments and costs, including court costs and attorneys' fees, incurred in connection with any action brought as a result of my participation in the Activities. This includes any claims for indemnity or contribution brought against the Released Parties.
